

**Annual General Meeting of the

- 3     The minutes of the AGM held on the 14<sup>th</sup> December 2020, having been circulated to members, and as no queries raised, approved.

- 6     Report from the Chair. Moved to the end of the meeting.
  
- 7     Presentation & approval of the Accounts 2020/21. It was confirmed that no queries or comments have been received and the balance carried forward is £5,500. One member commented that this was a large amount of uncommitted funds and asked if SSU3A have a statement or reserve policy. It was agreed the Committee would investigate this going forward and report back.

- 8     Presentation & approval of the new Constitution for SSU3A. Richard Walton then briefed the meeting on the reasons for presenting this document. Because of the difficulties faced by U3A's nationally over the past 18 months, a new Constitution template has been

produced by National and U3A's across the country, asked to adopt it. Members may not be aware that there are 16 U3A's running locally, and they have all been asked to consider this document which now embraces changes allowing for on line meetings etc.
